## RESOLUTION NO. 18/0307-03 RESOLUTION SUPPORTING SUBMITTAL OF AN APPLICATION TO REQUEST FUNDING FROM THE MINNESOTA DEPARTMENT OF TRANSPORTATION THROUGH THE CORRIDORS OF COMMERCE SOLICITATION

**WHEREAS**, the Minnesota Department of Transportation (MnDOT) is currently accepting candidate projects for the Corridors of Commerce Solicitation; and

**WHEREAS,** Chisago County is proposing an application for the expansion of US Highway 8 (US 8) from two lanes to four lanes between TH 61 in Forest Lake up to and

including the intersection of Karmel Avenue in Chisago City and adding intersection controls as needed to maintain neighborhood access along US 8; and

**WHEREAS;** this segment of US 8 provides access to residential, business, commercial, and recreational areas; and

**WHEREAS**; the US 8 corridor is continuing to experience a growth in traffic and congestion; and

**WHEREAS**; the current capacity is insufficient to meet today's demands and the growth anticipated in the future; and

WHEREAS; this project will protect and enhance mobility and safety; and

**WHEREAS;** the expansion of this roadway is essential to the economic health and welfare of the County and Region; and

**WHEREAS;** the project will be of mutual benefit to MnDOT, Chisago County, Washington County, the City of Chisago City, the City of Wyoming and the City of Forest Lake; and

**NOW THEREFORE BE IT RESOLVED,** that Chisago County supports the project and the application for funding as part of the Corridors of Commerce Solicitation.

## RESOLUTION NO. 18/0307-04 DESIGNATE AN OPPORTUNITY ZONE

**WHEREAS,** Congress established the Opportunity Zones as a new community development program in the Tax Cuts and Jobs Act of 2017 to encourage long-term investments in low-income urban and rural communities nationwide; and

**WHEREAS**, the Opportunity Zones program provides a tax incentive for investors to re-invest their unrealized capital gains into Opportunity Funds dedicated to investing into Opportunity Zones; and

**WHEREAS**, each Governor is authorized to designate 25% of the eligible census tracts as Opportunity Zones in their state. In Minnesota, the Governor can designate 123 census tracts as Opportunity Zones out of an eligible 491 low-income census tracts, and

WHEREAS, Governor Dayton is asking counties to prioritize and recommend which eligible census tracts in their county should be designated Opportunity Zones; and

**WHEREAS,** the parcel identified has opportunity for growth with two industrial parks that are underutilized and a vacant area designated for workforce-affordable housing; and

**WHEREAS,** after reviewing the principals and priorities for ranking provided by Minnesota, the Chisago County HRA-EDA supports and recommended submitting a response for the designation of an Opportunity Zone for Census Tract #110301,

**WHEREAS,** the parcel is located within the city limits of North Branch and the North Branch City Council supports the designation of Census Tract #110301as an Opportunity Zone, and

**NOW, THEREFORE, BE IT RESOLVED,** that the Chisago County Board of Commissioners hereby support the submittal of Census Tract # 110301 to Governor Dayton for designation as an Opportunity Zone.

On motion by Greene, seconded by Robinson, <u>the Board moved to authorize</u> <u>execution of the retainer agreement to engage with Briggs and Morgan, P.A., to assist with tax appeals for commercial/industrial properties, to be paid from the Contingency <u>Fund</u>.
