Commissioner Robinson offered the following resolution and moved its adoption:

**RESOLUTION NO. 11/1019-1
AUTHORIZATION TO REVISE AND UPDATE THE
CHISAGO COUNTY COMPREHENSIVE WATER MANAGEMENT PLAN**

WHEREAS, Minnesota Statutes, Chapter 103B.301, Comprehensive Local Water Management Act, authorizes Minnesota Counties to develop and implement a local water management plan; and

WHEREAS the Act requires that a county update and revise their local water management plan on a periodic basis; and

WHEREAS, the Act encourages that a county coordinate its planning with contiguous counties, and solicit input from local governmental units and state review agencies; and

WHEREAS, the Act requires that plans and official controls of other local governmental units be consistent with the local water management plan; and

WHEREAS, Chisago County has determined that the revision and continued implementation of a local water management plan will help promote the health and welfare of the citizens of Chisago County;

NOW, THEREFORE, BE IT RESOLVED, that the Chisago County Board of Commissioners delegates the Environmental Services/Zoning Department the responsibility of coordinating, assembling, writing and implementing the revised local water management plan pursuant to M.S. 103B.301 as implemented through the Water Plan Policy Team; and

BE IT FURTHER RESOLVED, that the Water Plan Policy Team shall coordinate its effort in the revision and update of the plan with all local units of government within Chisago County along with the state review agencies; and

BE IT FURTHER RESOLVED, that the Water Plan Policy Team shall incorporate, where appropriate, any existing plans and rules which have been developed and adopted by watershed districts having jurisdiction wholly or partly within Chisago County into its local water management plan; and

BE IT FURTHER RESOLVED, that the Water Plan Policy Team shall present any revisions or updates of the local water management plan to the Chisago County Board of Commissioner for consideration.

Commissioner McMahon seconded the resolution and upon a vote being taken thereon, the following voted: **IN FAVOR THEREOF:** McMahon, Walker, Greene, Montzka, Robinson

Whereupon the resolution was declared duly **passed** and **adopted**.
